Sir,

Medical Assessment and Rating Board for Homoeopathy has received an application for starting new Homoeopathic Medical College namely, Muhammad Wahed Homoeopathic Medical college and Research Centre Anwapada, Post.Anwa Tq Bhokardan, Dist. Jalna - 431112 Maharashtra with intake capacity of 100 seats in undergraduate course (BHMS) for the academic year 2024-25.

After considering the report of inspection carried out by Medical Assessment and Rating Board on dated 08/05/2024 and 09/05/2024, followed by physical hearing on 12.06.2024, MA&RB issued denial to college for 100 seats on 02.07.2024 in undergraduate BHMS course. The college made an appeal to the Commission dated 01.08.2024 and Commission vide Lr. no. 30-05/2024-25/NCH-GR (37) dated 05.09.2024 reiterated the decision of MARBH. College then made 2nd appeal to the Ministry on 07.09.2024 and on the recommendation of the Ministry, MA&RB examined the functionality of the college, and LOI with intake capacity of 60 seats was issued to the college on 29.11.2024 for A.Y. 2024-25. LOP Inspection was conducted on 04.12.2024. The following shortfalls were observed:

A. Hospital Functioning:

- a) USG facility was not available in hospital.
- b) OT, Yoga and Physiotherapy department were not functional.
- c) Form-16 from TRACES portal and EPF deduction proof of all hospital staff and other employees shall be submitted.

B. Teaching Faculty:

- a) Dr. Abhishek Kulkarni (Professor, Materia Medica): Experience of 03 years as Reader not provided.
- b) Dr. Mohammad Furqan (Professor, Organon), Dr. Neeta Labhane (Professor, Pharmacy) and Dr. Yogesh More (Lecturer, Repertory): Date on joining letter not mentioned.

College has to rectify the above shortfalls to fulfill the requirement as per section 29 of NCH Act 2020 (MSR) regulation 2013 whereas, MARBH has decided to issue Letter of Conditional

Permission to start a new Homoeopathic Medical College namely Muhammad Wahed Homoeopathic Medical college and Research Centre Anwapada, Post.Anwa Tq Bhokardan, Dist. Jalna - 431112 Maharashtra for undergraduate (BHMS) course with intake capacity of 60 seats for the Academic year 2024-25.

All shortfalls mentioned shall be rectified within a period of 30 days and a compliance report shall be submitted to the undersigned, failing which the permission issued will be withdrawn without further notice.

All admissions shall be made by NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/ UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.

The category-wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to college can be withdrawn or denied in the subsequent year if college is found non-deficient in compliance to MSR,2013 anytime during the academic year.

As per the provision of section 65 (4) of Maharashtra University of Health Sciences Act 1998, I am directed to inform you that, on the basis of Local Inquiry Committee report, and permission from Academic Council vide Resolution No. 250/2024 dated 20/12/2024 the Hon'ble Vice Chancellor is pleased to grant the First Time Affiliation to Muhammad Wahed Homoeopathy Medical College and Research Centre, Anwapada, Tal – Bhokardan, Distt – Jalna (Maharashtra) established by Riyazul Uloom Welfare Trust, A/PO – Anwa, Tal – Bhokardan, Distt – Jalna for the Academic Year 2024-25 with 60 intake capacity for B.H.M.S.
