Jalna-431112, Maharashtra for continuing BHMS course with intake capacity of 60 seats for the academic year 2025-26 under section 28 of NCH Act 2020-reg.

**Muhammad Wahed Homoeopathic Medical College and Research Centre, at Anwapada, Post. Anwa Tq. Bhokardan, Distt. Jalna-431112, Maharashtra has applied for permission for sanction of 60 seats in BHMS course for the academic year 2025-26.** The College has submitted the Part I information in which the entire functional profile has been narrated. MARBH conducted Inspection on 13.06.2025 & 14.06.2025 followed by Virtual hearing on 30-06-2025. The Medical Assessment and Rating Board has examined the College as to whether the college fulfils the Minimum Essential Standards as per the prevailing regulations under clauses 26 and 28 of the NCH Act 2020. On careful examination of the report, the Medical Assessment and Rating Board observed the following shortfalls: -

**1. Deficiency of Teaching Faculty (03 deficiencies)**

- Department of Anatomy: One Professor is not available.
- Department of Physiology and Biochemistry: One Professor is not available .
- Department of Organon of Medicine and Homoeopathic Philosophy and fundamentals of Psychology: One Associate Professor is not available.

As evident from the above statement, a total number of 03 UG teachers are deficient against the requirement of 19 + 1 for 60 seats UG college (As specified in MES, 2024) established in 2024. Pursuant to F.No.:3-2/MARBH/NCH/2025-26/162-169 dated 16/04/2025 issued by MARBH, a college up to 60 seats can avail 15% relaxation against the required number of teachers for Academic Year 2025-26 only. After allowing relaxation of 15%, college has no deficiency teaching faculty. However, such a relaxed number of teachers may be appointed at the earliest for smooth conduct of course.

**2. Deficiency of Hospital Staff:**

- One Pathologist is not available.

**3. Miscellaneous:**


- College has not applied for NABL accreditation for clinical laboratory.
- College is registered on AEBAS portal but college is not marking attendance.
- One Male Yoga Instructor is not available.

4. Considering the above observations during inspection and hearing, MARBH has decided to issue permission to **Muhammad Wahed Homoeopathic Medical College and Research Centre, At Anwapada , Post. Anwa Tq. Bhokardan, Distt. Jalna-431112, Maharashtra for continuing BHMS course with intake capacity of 60 BHMS seats for academic year 2025 – 26.**

5. All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of 60 seats for BHMS course shall be treated as All India Quota. Counselling for seats under All India Quota shall be conducted by the Central Government and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT designated by Central Government. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Govt. for All India Quota or the student admitted thereunder.
6. The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

(vii) *Settlement of advance(s) / dues of any section of the University including affiliation fees if pending with the College and any other deficiency observed by any regulating authority, please submit within 03 (three) months, otherwise, no action will be taken on teacher's proposal for approval / PG Recognition received from your College.*

**Important Note:**

- 1) This Conditional Continuation / Extension of affiliation is issued for the A.Y. 2025-2026 subject to the permission of National Commission for Homoeopathy / Government of India/Department of AYUSH, New Delhi. Further, if the permission is declined by the said authorities, this Conditional Continuation / Extension of Affiliation shall be treated as cancelled. The College is not authorized to admit students for 1<sup>st</sup> Year of the course until receipt of permission of the National Commission for Homoeopathy / Government of India /Department of AYUSH, New Delhi.
- 2) The admission shall be done through the Competent Authorities only.
